Workforce Innovation and Opportunity Act of 2014 (WIOA) partnerships exist to serve many purposes.

## **Some of these purposes are:**

- To better serve the customers (job seekers and employers)
- To better utilize funding (braided and sole-source funding)
- For service integration (holistic approach)
- For Innovation

# WIOA Partnerships



St. Clair County Intergovernmental Grants Department – Workforce Development Group (IGD Workforce) is Title I

Southwestern Illinois College – Adult Education Department (SWIC Adult Ed.) is Title II

Illinois Department of Employment Security (IDES) is Title III

Illinois Department of Human Service – Vocational Rehabilitation (Voc. Rehab.) is Title IV

## WIOA Partnerships



IGD has partnerships with all three of the other WIOA core partners.

The partnerships differ based on needs.

One partnership is having personnel resources together at the America's Job Center (One-stop) located at 7650 Magna Drive in Belleville.

## WIOA Partnerships



Under an annually negotiated Memorandum of Understanding (MOU) and budget, the four core partners deliver various employment, education, and training services to customers.

IDES refers Unemployment Insurance (UI) claimants directly to IGD for employment as dislocated workers.

IDES refers Unemployment Insurance (UI) claimants directly to VR for disability and access needs.

## WIOA Partnerships



VR refers customers to Adult Ed. For education and training opportunities.

Adult Ed. refers customers for programs they offer but cannot cover the costs of the education/training.

IGD refers customers to VR for disability and access needs.



## WIOA Partnerships



IGD refers customers to Adult Ed. for High School Equivalency (HSE) classes.

IGD Youth Program enrolls youth customers in Adult Ed. High School Equivalency (HSE) classes.
